1. Call to Order and Roll Call

Committee Chair Wm. Gregory Sawyer called the meeting to order at 2:30 p.m.

2. Public comment on items not on the agenda

There was no public comment.

3. Approval of the Personnel, Evaluation and Nominations (PEN) Committee minutes of September 24, 2020 (Action)

Commissioner Valladolid moved to approve the minutes. Seconded by Commissioner Geiogue.

In Favor (5): Geiogue, Mayer, Moore, Sawyer and Valladolid Carried (5 to 0)

The Committee **APPROVED** the minutes of the September 24, 2020 meeting.

4. Consideration of amendments to the Personnel, Evaluation and Nominations Committee charter (Action)

Committee Chair Sawyer presented item 4 of amendments to the Personnel, Evaluation, and Nominations committee charter.

Committee members engaged in a discussion on the charter amendments.

Commissioner Mayer recommended to include language that explains the Committee's collaboration with the Executive Director on developing annual goals for the Commission. General Counsel, Julia Blair, suggested that the recommendation can be included in the first paragraph of the charter.

Committee Chair Sawyer and Commissioner Geiogue agreed to remove the function of "developing an inclusive process for the annual election of Commission officers, ensuring that all Commissioners who are willing to serve as officers be considered for election."

Committee Chair Sawyer added to change the third statement "if directed by the Commission Chair" to "as directed by the Commission Chair."

Commissioner Valladolid moved to approve the charter document with suggested changes. Motion did not move to vote.

Commission Mayer moved to approve the proposed amendments with the suggested motion language. **Seconded by** Commissioner Moore.

In Favor (5): Geiogue, Mayer, Moore, Sawyer and Valladolid Carried (5 to 0)

The Committee APPROVED the proposed amendments to the PEN committee charter with amendment language to be drafted by General Counsel and reviewed by the Committee Chair that will add the charge of collaborating with the Executive Director to define their annual goals and presenting recommendations to the Commission, amend charge three with replacing "developing" with "periodically reviewing and providing input," and amend charge four to aligning the timing of the review with the language in the governance policies and procedures and insert "to the Commission" after recommending.
