Dear Michelle Dean,

I am writing to ask that you please reconsider your decision regarding Gnomon's continued participation in the Cal Grant Program.

It is my understanding that your decision has been based on our reporting of IPEDS data on our website. **Unfortunately, this information is misleading as well as detrimental to students in need** – which is explained more fully below. The Federal government requires that we post our 'first-time, full-time' graduation rates for the cohort year, and our current graduation rate was zero percent (0%).

However, what this information is *not* telling you is that Gnomon had *only one* 'first-time, full-time' graduate in the cohort year, and while this student did graduate, they did not graduate within 100% of the program due to taking a Leave of Absence, therefore the graduation rate for 'first-time, full-time' completers within 100% of the program length can only be 0%.

Attached to the email are PDFs with the latest graduation and placement rates as reported to BPPE. These have also been recently emailed to CSAC per SB70 requirements. Likewise, the Enrollment, Persistence and Graduation information has been uploaded to WebGrants. All of these show the success Gnomon has with our students and the injustice of being singled out because we have very few students that meet the 'first-time, full-time' criteria.

I have also attached the prior years' Completion/Graduation from our disclosures page for comparison. All of these past disclosures show the same thing: The issue for us ongoingly is the lack of 'first-time, full-time' students that enter Gnomon.

Gnomon is a high-tech digital animation school that is difficult to get into and requires a level of proficiency that students coming right out of high school rarely have. Many students take individual classes at Gnomon in order to build up a portfolio that will get them accepted into a program by Admissions.

This prior experience would mean that they would not meet the 'first-time, full-time' criteria. (Of course, it is this same entrance eligibility that ensures Gnomon is always compliant, never enrolls a student into a program that is ill-prepared and certifies that all students who enter will benefit from our program. Our placement records prove this.)

In addition, many students take Gen Ed courses at a community college and transfer the units in to drive down the overall cost of attending Gnomon.

The 'first-time, full-time' criteria also works against us in our ability to secure additional Title IV funding since so few of our students that are Pell grant recipients meet the criteria.

If there is anything we can provide to you to show that our students graduate and are placed, please let me know. Gnomon's only goal is to support our students in their study so they may contribute to their community in seen and unseen ways. For these reasons, the School desires a reexamination of your findings, and hopefully, a reconsideration of the decision regarding Gnomon's continued participation in the Cal Grant Program.

Student's Right to Cancel

Cancelling on Or Before The First Day Of Class

If tuition and fees are collected in advance of the start date of classes and the Student does not begin classes or withdraw on the first day of classes, Gnomon retains the non-refundable Enrollment Deposit of \$125.00 and will process a refund for all other tuition and fees paid. Refunds will be paid within 45 days.

Cancelling During the First Seven (7) Days After Enrollment

- 1) The Student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. Gnomon shall refund 100 percent of the amount paid for institutional charges, less a reasonable deposit or application fee not to exceed two hundred fifty dollars (\$250), if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment, whichever is later.

Withdrawing After the First Seven (7) Days After Enrollment

- 1) You have the right to withdraw from the program of instruction at any time.
- 2) After the cancellation period, Gnomon will provide a pro-rata refund of nonfederal student financial aid program monies paid to students who have completed 60% or less of the period of attendance within the current quarter. The period of attendance is defined as a 10-week term of instruction. The program includes a defined number of 10-week quarters. Students who withdraw from the program are not financially obligated beyond the current quarter.
