Update on the Grant Delivery System Modernization launch

## SUMMARY:

This item provides an update on the launch of the California Student Aid Commission's (Commission) Grant Delivery System Modernization (GDSM) for the WebGrants for Institutions System and the next phase of deliverables.

#### **RECOMMENDATION:**

This is an information item; no action is required

## **BACKGROUND:**

The Commission began the planning phase of the GDSM Project in the 2013-14 fiscal year based on the inadequacies of the 30-year-old Grant Delivery System (GDS) technology. The GDS (WebGrants for Students, California Dream Act, Chafee, National Guard and WebGrants for Institutions) had limited capability, aging technology, and disjointed functionality which caused new legislative required programs to be supported through either manual processes or the development and implementation of additional one-off systems. The GDS had several critical single points of failure and limited disaster recovery capability.

The GDSM Project Teams worked collaboratively with key stakeholders and student groups, parents, institutional financial aid administrators, high school counselors, and other interested organizations to understand the priority needs for the GDSM project to address. The functions of the modernized system were identified, developed, and finalized through the California Department of Technology Project Approval Lifecycle (PAL) process.

The GDSM Project Team officially kicked off the GDSM project development in October 2018 and is now entering its' fourth and final year (two years of development and two years of maintenance and operations). To date, the team has developed, tested, and released the modernized portals for WebGrants for Students, Chafee online application, National Guard, and most recently the WebGrants for Institutions. Over 450,000 accounts have been created in GDSM for various applications and thousands of users have logged in to check their award status, change passwords and provide demographic information, make school changes, complete supplemental application forms, and manage their awards.

The new modernized WebGrants system is a state-of-the-art infrastructure with no single point of failure and has a built-in disaster recovery. The new upgraded applications are secure, modular, scalable, and have a single sign-on system with advanced features that allow the users to access their information in a secure environment. The new enhanced tools help guide students through their application and award process.

The second phase of GDSM included WebGrants for Institutions, California Dream Act Application, and stabilization of newly launched production applications. On May 10, 2021, WebGrants for Intuitions was successfully launched into production with no disruption to the institutions or students. The GDSM Project Team provided training webinars and videos on the new WebGrants screens to prepare users for accessing the new modernized system in advance of the launch.

The California Dream Act Application will be launched in June 2021. The GDSM Project Team has scheduled various quarterly releases to stabilize production applications as well enhancements.

#### **ANALYSIS:**

The agile method was adopted for this project, which allowed the project team to deliver code and other necessary artifacts at the end of two-week sprints. Deliverables included mockup designs, business input, code development, testing, documentation, and final release on production servers. This allowed the team to plan a major release of the application every three months.
