Whereas, Dr. Moore was first appointed as the California Community College representative to the California Student Aid Commission in December 2011 by then Governor Edmund G. Brown, Jr. and was subsequently re-appointed in November 2013 and again in October 2017 to continue her service and passion for making a college education affordable and attainable for all students. She is currently the longest-serving member on the Commission.

Whereas, Dr. Moore has served admirably as a Commissioner; as the Commission Vice Chair since 2019, and in numerous roles on the ad hoc Dream Act Committee since 2012, the Student Impact Committee since 2013, the Legislative, Audit and Budget Committee since 2015, the Strategic Policy and Planning Committee since 2016, and the Personnel, Evaluation and Nominations Committee since 2019, including serving as Vice Chair and Chair to these committees respectively. Additionally, she has served on several work groups, including the California Student Loan and Debt Service Review Work Group, the Cal-Fresh Work Group and the Cal Grant Reform Work Group; and,

Whereas, Dr. Moore earned a Doctorate in International and Multicultural Education from the University of San Francisco and a Master of Arts degree in Intercultural Communication and Public Policy. She also earned a Bachelor of Arts in Communication Studies from California State University, Sacramento; and,

Whereas, Dr. Moore currently serves as the President of Cañada College, an award-winning institution and was Vice Chancellor for Educational Services and Planning of the San Mateo County Community College District, Chancellor of the Venture County Community College District, President of Los Angeles City College, Senior Vice Chancellor for Governmental and External Relations for the California Community College Chancellor's Office, and Interim Superintendent President of Compton Community College; and,

Whereas, Dr. Moore is a member of the Association of California Community College Administrators, Educating Young Minds, Thomas Lakin Institute for Mentored Leadership Council, National Council on Black American Affairs, and the Southern California Chapter of the International Women's Forum; and,

Whereas, Dr. Moore has had a long career in service to others including establishing the campus' anti-racist framework, a program to support Latinx students with transfer pathways to San Francisco State and co-chairing the San Mateo County Community College District's Basic Needs Task Force; and,

Whereas, Dr. Moore has consistently demonstrated strong leadership, exemplary public service, and successful involvement in various causes to help students; and,
