

## Summary of Systemwide Tuition and Fee Rates Approved by the Regents in July 2021

In July 2021, the UC Board of Regents approved a multi-year Tuition Stability Plan that affects Tuition, the Student Services Fee, and Nonresident Supplemental Tuition (NRST) for undergraduates and graduate students. This document describes the resulting student charges for 2022-23 and projected rates for later years.

## For <u>undergraduate</u> students:

- Students who enrolled prior to fall 2022 will continue to pay current (2021-22) rates through 2026-27.
- For students entering fall 2022 and later, all three charges will be assessed **on a cohort basis** i.e., charges for each entering cohort will be higher than the amounts charged to prior cohorts, but will remain flat for the duration of a student's enrollment, up to six years.
- Annual adjustments from one cohort to the next will decline over time, from inflation plus 2% for fall 2022 to inflation only for fall 2026.

## For graduate students:

- All three charges will continue to be assessed on a uniform basis—i.e., new and continuing students will
  pay the same rate, regardless of a student's entering cohort.
- Commencing fall 2022, Tuition and the Student Services Fee will be adjusted annually based on inflation.
- Graduate Nonresident Supplemental Tuition will remain unchanged.
- Professional Degree Supplemental Tuition (PDST) rates are unaffected and will continue to reflect the amounts approved by the Regents as part of each program's multi-year PDST plan.

Actual and projected rates are shown below to assist campuses with their planning efforts. Additional information about the transition to cohort rates for undergraduates—including undergraduate rates for summer 2022 and beyond, charges for students in the UC Education Abroad Program, and many other details—will be described in implementation guidelines to be issued later this summer.
