ADOPTION OF PROPOSED EMERGENCY REGULATIONS FOR THE GOLDEN STATE TEACHER GRANT PROGRAM (Education Code section 69617)

January 21, 2022

WHEREAS, Education Code section 69617 (enacted pursuant to Stats. 2019, Ch. 51, Sec. 58; amended pursuant to Stats. 2021, Ch. 262, Sec. 9) establishes the Golden State Teacher Grant Program to provide one time grants of up to \$20,000 for students enrolled in teacher credential programs leading to a credential in high need fields and who commit to teaching at priority schools for four years after receiving a credential; and

WHEREAS, section 69617(g) authorizes the California Student Aid Commission to adopt regulations necessary to implement the program and further authorizes that those regulations may be adopted as emergency regulations; and

WHEREAS, Commission staff has developed proposed emergency regulations to implement section 69617 for consideration by the Commission; and

WHEREAS, Commission staff intends to conduct the rulemaking process, which includes the submission of the proposed draft emergency regulations, conduct a five day notice period, and then submit to the Office of Administrative Law for approval.

NOW, THEREFORE, BE IT RESOLVED by the California Student Aid Commission as follows:

Section 1. The proposed emergency regulations to implement Education Code section 69617 are hereby approved in substantially the form presented to the Commission. The Executive Director is hereby authorized, for and on behalf of the Commission, to submit such emergency regulations, with all required supporting documentation, to the Office of Administrative Law and proceed as required under the Administrative Procedures Act.

Section 2. The Executive Director is hereby authorized and directed to take such actions, including making or causing to be made such changes to the regulations as may be required for approval of the regulations by the Office of Administrative Law, and to execute and deliver any and all documents and take any and all steps that the Executive Director may deem necessary or advisable in order to effectuate the purposes of this resolution.

Section 3. This resolution shall take effect immediately upon its approval.
