

RESOLUTION NO. 22-03

**APPROVAL OF EXTENSIONS FOR EMERGENCY
REGULATIONS AND THE INITIATION OF THE
PERMANENT RULEMAKING PROCESS
GOLDEN STATE TEACHER GRANT PROGRAM**
(Education Code section 69617)

June 23, 2022

WHEREAS, Education Code section 69617 establishes the Golden State Teacher Grant Program (Program) to provide grants of up to \$20,000 to students in eligible teacher credential programs and who commit to certain requirements related to working in high need fields in high priority schools after receiving their credential; and subsection (g) of section 69617 authorizes the Commission to adopt regulations for the administration of the Program; and

WHEREAS, emergency regulations for the Program were adopted by the Commission and approved by OAL on February 10, 2022 and those regulations are set to expire on August 8, 2022; and

WHEREAS, Commission staff intends to conduct the permanent rulemaking process, which includes a stakeholder meeting held in June 1-2, 2022, proposed amendments for Commission consideration at its September board meeting, the submission of the approved draft regulations to the Office of Administrative Law (OAL), distribution for public comment, consideration of any such comments, making non-substantive changes to the regulations, and addressing any issues raised by OAL; and

WHEREAS, the Administrative Procedures Act authorizes the Commission to request up to two 90-day extensions of the emergency regulations while the permanent rulemaking process is underway; and

WHEREAS, Education Code section 69513.1 provides that the Commission “may delegate to the director any power, duty, purpose, function, or jurisdiction that the commission may lawfully delegate, including the authority to enter into and sign contracts on behalf of the commission. The director may redelegate any of those powers, duties, purposes, functions, or jurisdictions to his or her designee, unless by statute, or rule or regulation, the director is expressly required to act personally”.

NOW, THEREFORE, BE IT RESOLVED by the California Student Aid Commission as follows:

Section 1. Staff is authorized to initiate the process for promulgating permanent regulations for the Golden State Teacher Grant Program pursuant to Education Code section 69617(g), including consulting with stakeholders and proposing amendments to the existing emergency regulations.

Section 2. Staff is authorized to submit up to two 90-day extension requests to the Office of Administrative as necessary and appropriate to ensure that the emergency regulations remain in effect during the pendency of the permanent rulemaking process.

Section 3. This resolution shall take effect immediately upon its approval.
