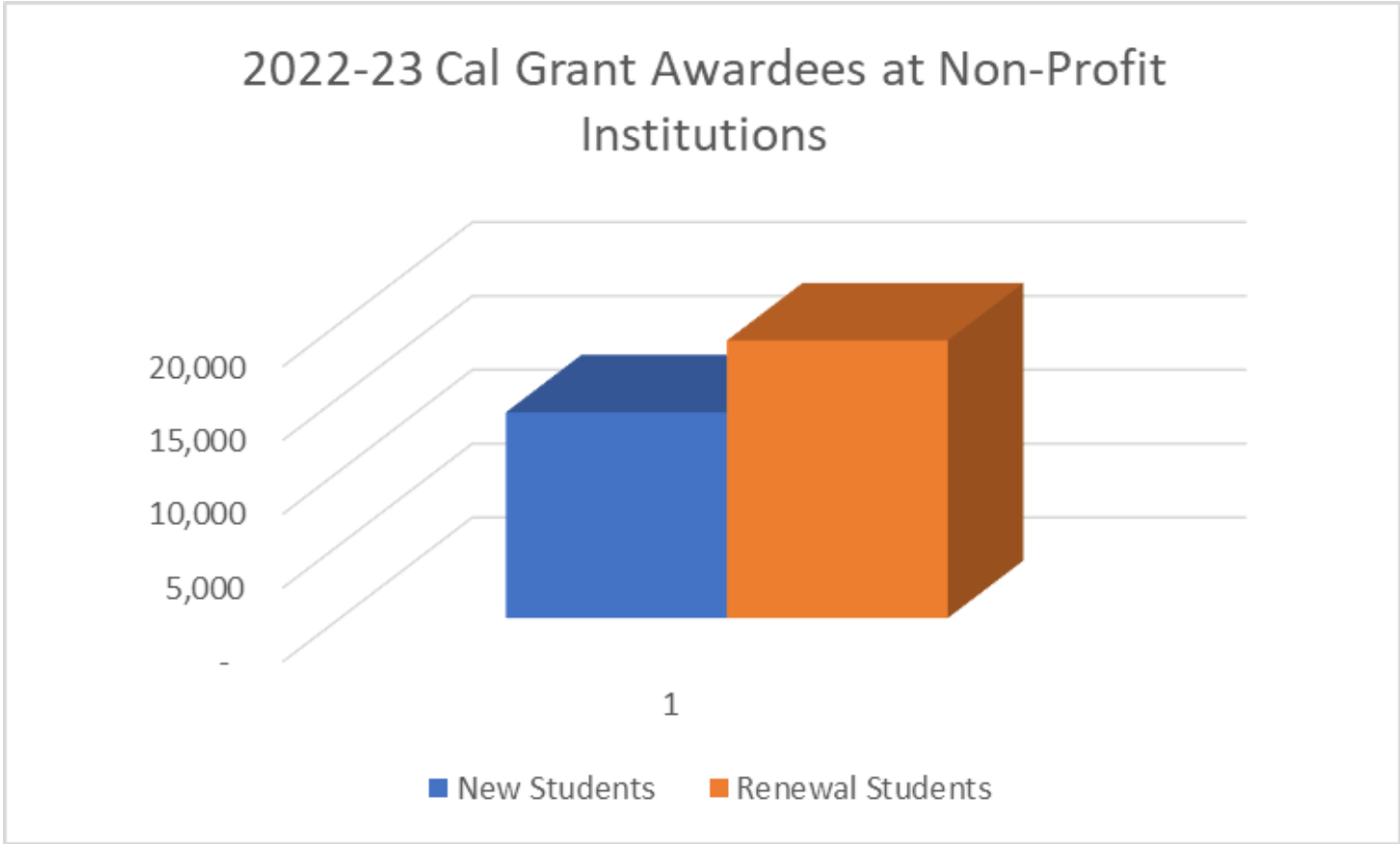
Private Non-Profits



2022 -23 Cal Grant Changes

Private Non -Profit Institutions

- 1 Maximum Cal A and B tuition award for Cal Grant recipients increased from \$9,220 to \$9,358.
- 32,740 Cal Grant students benefitted from this award increase



2022-23 Cal Grant Changes

Private Non-Profit Institutions

2 Students with Dependent Children

- Up to \$6,000 for Cal Grant A and B recipients
- Up to \$4,000 for Cal Grant C recipients
- 125 students with potential eligibility for this increased access award

3 Awards for Foster Youth and Former Foster Youth

- Up to \$6,000 for Cal Grant A and B recipients

2022 -23 Changes

CA Dream Act Service Incentive Grant (DSIG)

2022-23 changes

- Increased the total stipend award amount to \$4,500/year
- Removed the “proration” of awards per enrollment status
- Extended eligibility to Cal Grant A awardees who meet Cal Grant B eligibility
- Reduced total participants to 1,667 (decrease from 2,500)
- Set the minimum amount of a grant awarded in a semester or quarter at \$450
- Unexpended or unencumbered funds appropriated for DSIG, will be transferred to the UC and the CSU to support the California DREAM Loan Program (upon order of the Director of Finance)

California Volunteers Partnership

CSAC CA Dream Act Service Incentive Grant - #CaliforniansForAll College Corp

- 1 Beginning in 2022-23, California Volunteers in partnership with the California Student Aid Commission (CSAC) will be offering #CaliforniansForAll College Corps to AB 540 California Dream Act students.
- 2 College Corp Fellows who complete 450 hours of service will receive the following:
 - \$5,500 stipend (living allowance) & \$4,500 Education Award
- 3 The Education Award for AB 540 California Dream Act students will be administered through the California Dream Act Service Incentive Grant Program at CSAC.

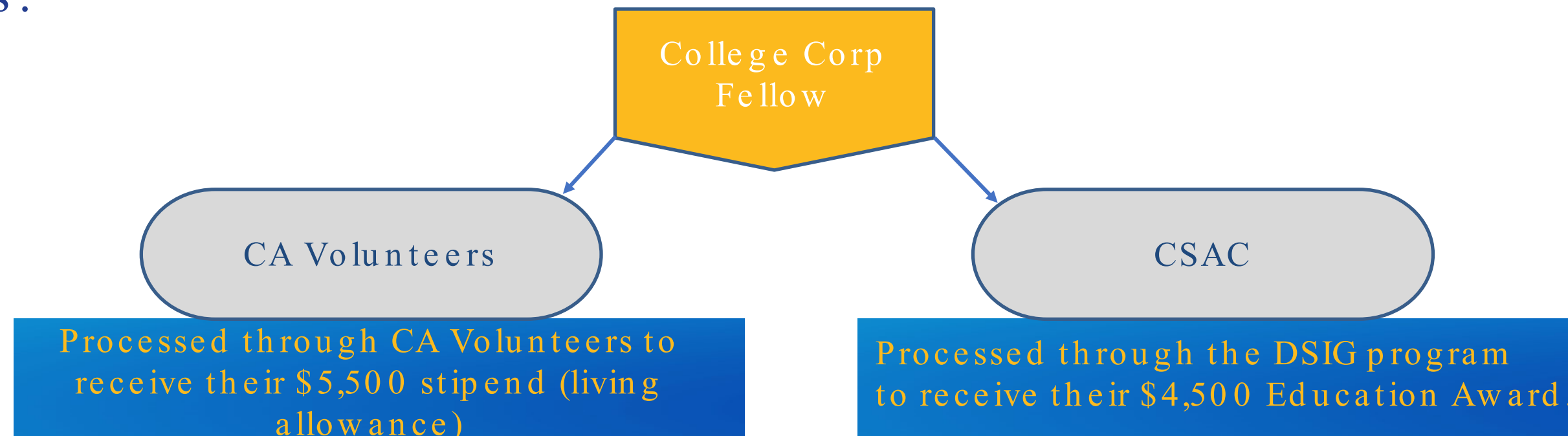
Education Award - DSIG

- DSIG program, encourages eligible California Dream Act Applicants to perform community or volunteer service.
- \$4,500 per academic year (up to \$2,250 per semester or up to \$1,500 per quarter) to eligible students.
- 300 hours per academic year (150 hours per semester or 100 hours per quarter) of community or volunteer service.
- Fellows must complete additional 150 service hours to meet the 450 total service hours requirement to receive the total \$5,500 living allowance through College Corps.

How It Works

CSAC CA Dream Act Service Incentive Grant - #CaliforniasForAll College Corp

- 1 Eligible students will be determined by partner campuses during onboarding and registration in the College Corps program.
- 2 Fellows must also meet the requirements of the College Corps and DSIG program.
- 3 Campus Leads will facilitate the DSIG workflow for College Corps fellows.

2022-23 Changes

GSTG

- Removes the high-need field requirement for preliminary teaching credentials.
- Expands eligibility to those pursuing a pupil personnel services credential.
- Students must complete their program and obtain their credential within 3 years after their first GSTG payment.
- Funds can be paid over multiple years, not to exceed \$20,000.
- Requires the Commission to post a Priority School List by April 15 annually.
- Extends timeframe to work 4 years at a priority school from 5 to 8 years.



2022-23 Changes

GSTG

- Expands applications to students who have applied for enrollment in an eligible professional preparation program.
 - Provides pre-enrollment conditional award notices to applicants.
 - Allows institutions to provide applicants with grant eligibility determinations.
- Opens applications for the following academic year on September 1 annually.
 - The 2023-24 application opened on September 1, 2022.

- Released new payment roster file layout to UC and CSU campuses on August 22nd
- Initial awards anticipated in mid to late September

2022-2023 Application Live

- Expanded application, where applicants without FAFSA/CADAA can input their income information directly into the application
- Applicants without a social security number or California Dream Act ID can apply.

2

Inclusion of Eligible Training Programs

- Finalizing process for programs on EDD's Eligible Training Program List to apply and be included in the GSETGP.

3

Future Webinars

- Planning webinars to inform audiences of the GSETGP and clarifying responsibilities of training program/institution staff (including verifying applicant enrollment in the online system of WebGrants).

Quick Review

Learning-Aligned Employment Program (LAEP)

1 Work-based Learning

LAEP offers eligible students at public colleges the opportunity to earn money to help defray their educational costs while gaining education-aligned, career-related employment.

2 Goals

Promotes college affordability, equity, and smoother transition from college to career

3 Funding

The combined 2021-22 and 2022-23 state budget funding for LAEP is \$500 million. Institutions can use this funding until 2031.

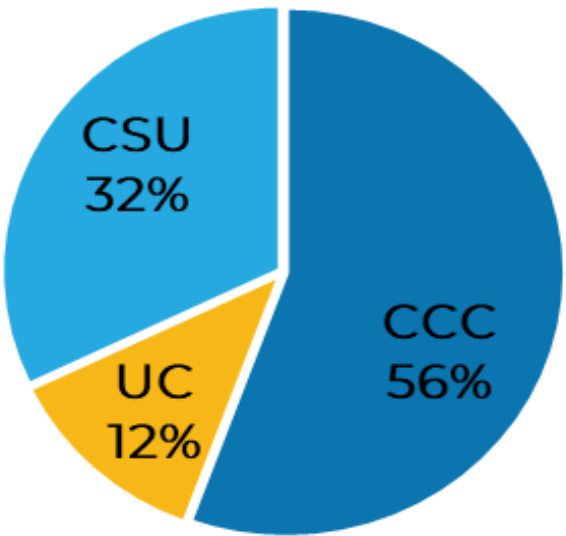

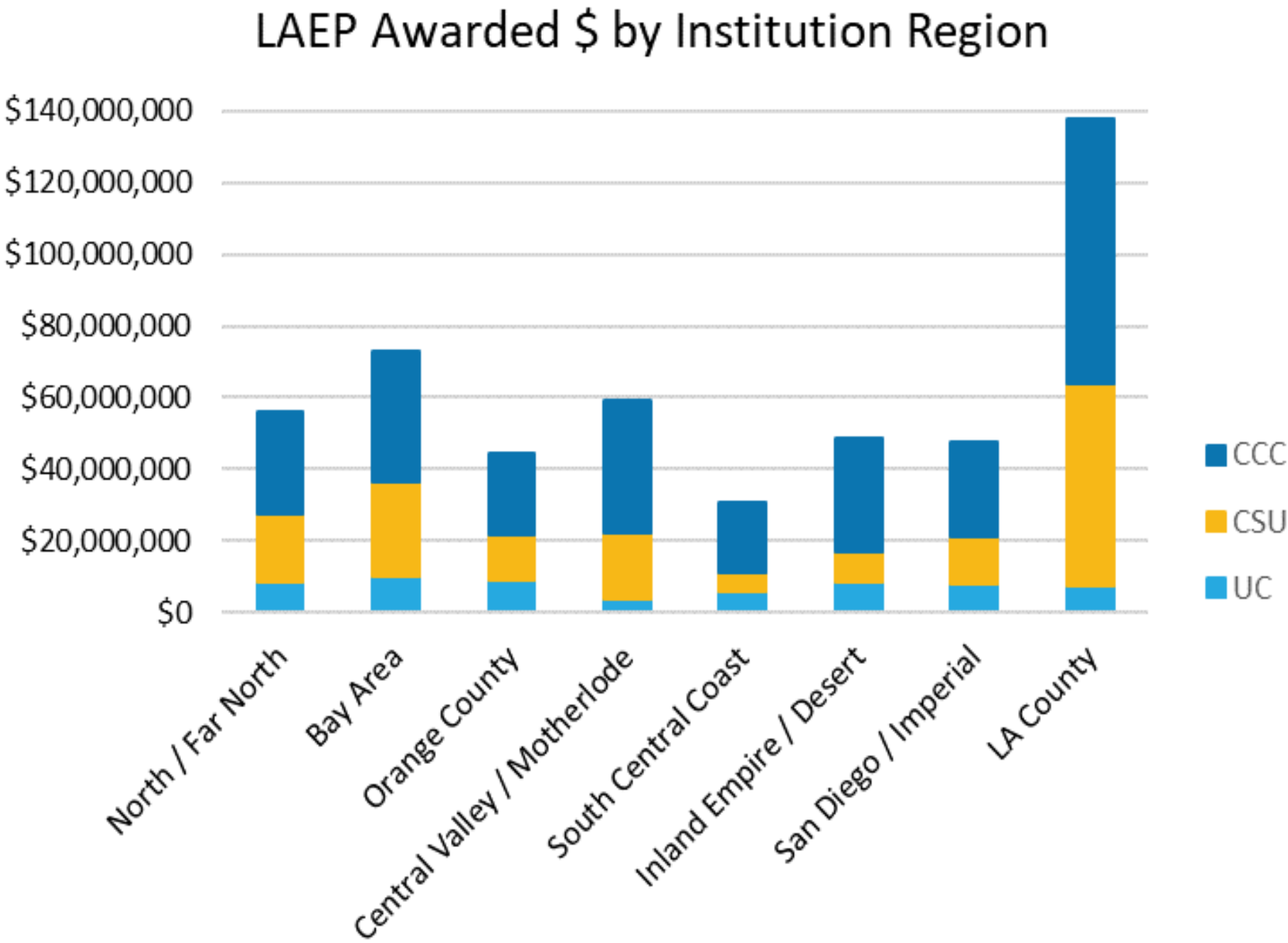
