Eligibility for Cal Grant Participation 2023-24

Dear Deputy Director Kang,

This letter is a follow-up to our prior ineligibility status to participate in the Cal Grant program and serves as Columbia College Hollywood's (CCH) request for eligibility reconsideration pursuant to California Education Code section 69432.7(l)(3)(I)(iv)(I) for the 2023-24 academic year.

I. CCH's Prior Ineligibility

On December 2, 2020, the Commission deemed CCH ineligible for the 2021-22 academic year based on our Cohort Default Rate (CDR) released in 2020 of 15.9%. On December 23, 2020, CCH respectfully requested the Commission exercise its appeal authority and reinstate CCH's eligibility. The Commission denied CCH's request on March 2, 2021.

CCH reapplied for Cal Grant program participation for the 2022-23 academic year given that we met participation eligibility requirements—CCH's 2021 released CDR was 0.0%. However, on November 19, 2021, the Commission communicated that pursuant to an amendment to the Code by Governor Newsom on September 23, 2021, the Commission was directed to use the 2020 CDR for an otherwise qualifying institution in determining eligibility for the 2022-23 academic year. CCH was therefore unable to offer Cal Grant funding to many of our need-based students in a year where we would have been otherwise eligible.

II. Request for Reconsideration for 2023-24 Academic Year

Governor Newsom signed AB 190 into law on September 27, 2022, which provides in relevant part:

(III) Notwithstanding subclause (II), the commission may grant an appeal for the 2023–24 academic year if the institution failed to meet the three-year cohort default rate solely due to acquisition of an out-of-state institution that impacted its three-year cohort default rate, and the acquired out-of-state institution has since closed any time between the 2019–20 to 2022–23 academic years, inclusive. The institution's Cal Grant eligibility shall not be transferrable if the institution is bought or sold during the 2023–24 fiscal year. This authority shall be in effect for an appeal for the 2023–24 academic year only and shall sunset on July 1, 2023. The institution's Cal Grant eligibility shall not be transferrable to a new site acquired by the institution.

As explained in detail below, CCH did not meet the Commission's required 15.5% CDR for the 2021-22 academic year solely due to a 2018 acquisition of an out-of-state (Illinois) institution, which impacted the college's CDR. CCH's Illinois campus (Flashpoint Chicago) closed on August 9, 2022. As such, CCH respectfully requests that the Commission exercise its appeal authority under California Education Code section 69432.7(l)(3)(I)(iv)(I) and reconsider CCH's eligibility for the 2023-24 academic year.

A. CCH Failed to Meet the 2020 Certification Due to Acquisition of Out-of-State Institution

In 2018, CCH acquired a branch campus in Chicago, Illinois - Flashpoint Chicago. At the time of the acquisition, 38 of the eventual 42 total defaulters from the Chicago campus were already in defaulted status. CCH was proactive in utilizing Wright International Student Services (WISS) as an outside default prevention service. Despite the efforts of WISS and CCH in trying to cure delinquent borrowers, four additional Illinois students and four California students defaulted by the end of the cohort tracking period—resulting in a total of 46 defaulted borrowers. Of these 46 defaulted borrowers (out of 289 total borrowers), 42 were from the Illinois campus. If the campuses were separated out, CCH's 2020 released CDR would have looked like this:

Campus	Defaulters	Total Borrowers	Percentage

The 42 Illinois defaulted borrowers were inherited because of our acquisition of an out-of-state institution. As demonstrated in the chart above, CCH failed to meet the 2020 released CDR solely due to the acquisition of the Illinois campus. Without the borrowers from the Illinois campus, CCH would have had a 4% CDR for 2020, well below the Commission's 15.5% CDR eligibility requirement. Moreover, CCH's 2021 CDR was 0.0%, and our 2022 CDR is 0.0%.

II. CCH's Acquired Out-of-State Institution is Closed

September 8, 2022 was the last day the institution provided any instruction at the CCH's Illinois campus. As required under California Education Code section 69432.7(l)(3)(I)(iv)(I), CCH's acquired out-of-state institution (which impacted the CDR) closed within the 2022-23 academic year.

III. Conclusion

The defaulted borrowers CCH inherited as a result of the acquisition of an out-of-state institution was the sole reason CCH did not meet the Commission's 15.5% CDR requirement for the 2021-2022 academic year. Without the out-of-state institution acquisition, CCH's CDR would have been 4%. CCH's Illinois campus closed within the 2022-23 academic year on August 9, 2022. Therefore, CCH has met the requirements set forth in California Education Code section 69432.7(1)(3)(I)(iv)(I), and respectfully

requests that the Commission exercise its appeal authority and reconsider CCH's eligibility to participate in the Cal Grant program for the 2023-24 academic year.

CCH understands that the authority for this specific and limited appeal is only in effect for the 2023–24 academic year. After which, the college must meet the Commission's eligibility criteria of a three year cohort default rate below 15.5% and a graduation rate above 30%. CCH has consistently met the graduation requirement, and we are confident that our internal efforts at the California campus will continue to result in a CDR well below the 15.5% threshold.
