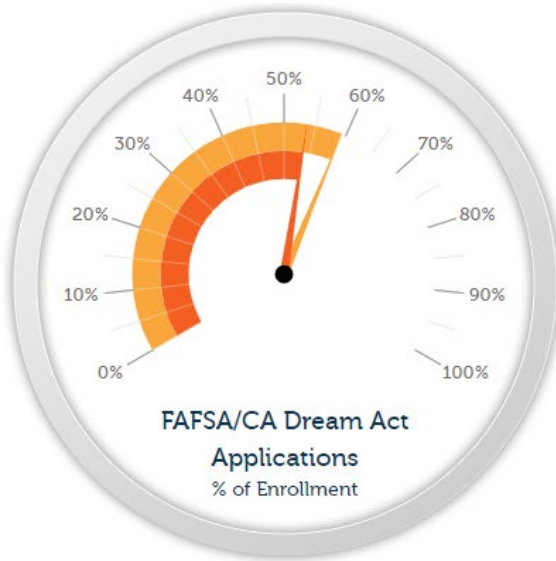
Race to Submit Summary

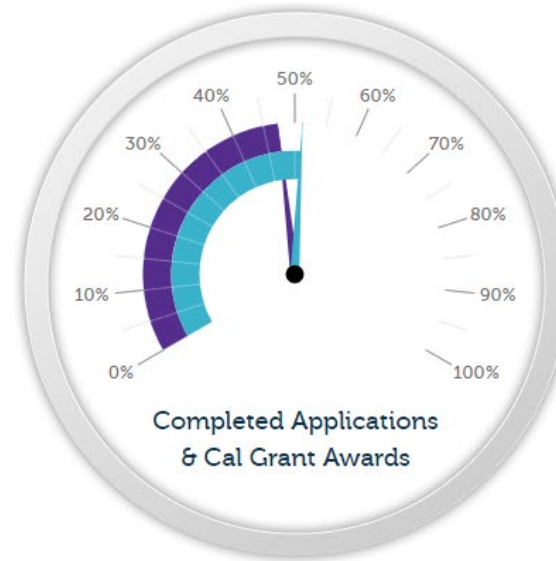
