1. Call to Order and Roll Call

Executive Director Garcia provided a brief background on the chatbot. She introduced each of the guest speakers: Corey Edwards, with Mainstay and Mike McCormick, Superintendent of Val Verde Unified School District.

Mr. Edwards presented the history and background of Mainstay. Mr. McCormick presented the assistance that Val Verde USD would provide and how crucial the chatbot would be in helping students with financial aid application.
