RESOLUTION NO. 24-01

ADOPTION OF PROPOSED REGULATIONS FOR THE PUBLIC INTEREST ATTORNEY LOAN REPAYMENT PROGRAM

(Education Code Section 69740, et seq.) January 19, 2024

WHEREAS, Education Code section 69740, et seq. (enacted by Stats. 2001, Ch. 881, Sec. 2. (AB 935) Effective October 14, 2001.) establishes the Public Interest Attorney Loan Repayment Program (Program) for licensed attorneys who practice or agree to practice in public interest areas of the law in this state.

WHEREAS, Commission staff created an Advisory Committee pursuant to Education Code section 69740(i); and

WHEREAS, Commission staff developed proposed regulations based on the Advisory Committee's efforts;

WHEREAS, Education Code section 69513.1 provides that the Commission "may delegate to the director any power, duty, purpose, function, or jurisdiction that the commission may lawfully delegate, including the authority to enter into and sign contracts on behalf of the commission. The director may redelegate any of those powers, duties, purposes, functions, or jurisdictions to his or her designee, unless by statute, or rule or regulation, the director is expressly required to act personally;" and

WHEREAS, Commission staff intends to submit these proposed regulations for a 45-day public comment period following Commission approval, and complete the regulatory process following such public comment period to ensure publication of these regulations.

NOW, THEREFORE, BE IT RESOLVED by the California Student Aid Commission as follows:

Section 1. The proposed regulations, establishing Article 19 of Chapter 1 of Division 4 of Title 5 of the California Code of Regulations to administer and manage the Public Interest Attorney Loan Repayment Program established pursuant to Education Code section 69740, et seq., are hereby approved in substantially the form presented to the Commission.

Section 2. The Executive Director is hereby authorized and directed to submit the proposed regulations to begin the 45-day public comment period and complete the regulatory process to ensure publication of these regulations. The Executive Director is further authorized to take all actions necessary to complete the regulatory process, including reviewing submitted public comments and making non-substantive changes to the regulations resulting from such comments, making or causing to be made such changes to the regulations as may be required for approval of the regulations by the Office of Administrative Law including making non-substantive changes requested by the Office of Administrative Law, and to execute and deliver any and all documents and take any and all steps that the Executive Director may deem necessary or advisable in order to effectuate the purposes of this resolution.

Section 3. This resolution shall take effect immediately upon its approval.
