2023-24 High School Entitlement

- Increased awards
 - AY 2022 (12/30/22): 154,861
 - AY 2023 (12/28/23): 165,323 (+7%)

- Increased confirmations (+20%)
 - Required for payment

2023-24 High School Entitlement

 Continuing to see increased payments overall

 But payment is low for confirmed-only awards

2023-24 CCC Entitlement

- Increased awards with confirmed enrollment
 - AY 2022 (1/3/23): 92,871
 - AY 2023 (1/2/24): 113,613 (+22%)

- Increased payments
 - AY 2022 (3/6/23): 52,077 (52.7%)
 - AY 2023 (3/4/24): 64,694 (53.8%, +12,617)





CCC Entitlement Survey


- 31,281 new awardees had confirmed enrollment but no payment activity
- Survey to determine eligibility and identify issues, sent Feb 7
 - Enrollment status
 - Receipt of other aid, knowledge of Cal Grant award
 - Contact with college financial aid office or CSAC
 - Open response

Over 6,000 students responded



CCC Entitlement Survey Results

- Enrollment: 87% confirmed fall classes
 - 70% of those enrolled at least half-time
 - Of those not enrolled in fall, 63% are enrolled for spring
 - 90-95% reported same school as awarded





CCC Entitlement Survey Results

- Financial Aid Receipt
 - Community College Promise Grant (Fee Waiver): 55%
 - Received Aid Disbursement: 32%
 - Aware of Cal Grant Award: 31%
- Contact with:
 - College financial aid office: 15% (38% SAP, 33% Verification, 26% Disbursements)

• CSAC: 9%



CCC Entitlement Survey Results

- Initial open response themes
 - SAP
 - Lack of information/communication
 - Verification difficulties
 - Not aware of Cal Grant or how to claim award



CCC Entitlement Survey – Next Steps

• Of the 31,281 students unpaid: 931 paid and 2,897 ineligible reason
